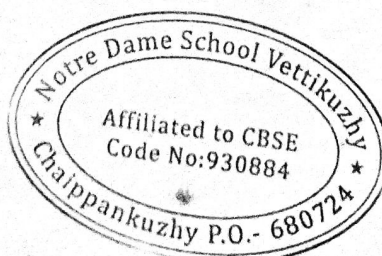
## ORDER

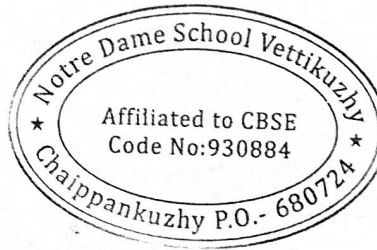
